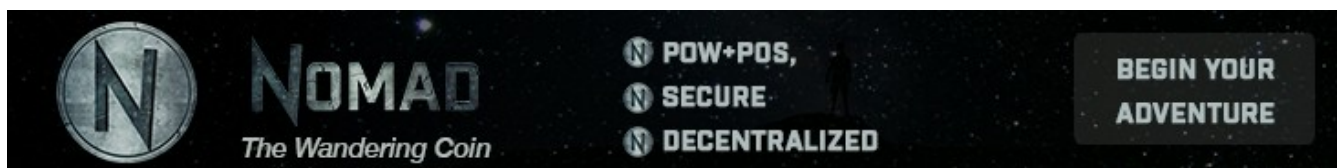

Abstract

Nomad Coin has a HMQ1725 algo which stands for "Highly Modified Quark 17 algorithms 25 hash rounds". The algo enhances on quark with 17 different algorithms going through 25 rounds of hashing. It is asic proof, meaning it can only be mined with a cpu or gp that aims to become the preferred method to provide digital nomad merchants a payment method based through the Bitcoin blockchain and to access the products or services provided by the Nomad coin merchants. The adoption of cryptocurrencies will impact the way we make purchases in the future and Nomad Coin is poised to play a leading role in this new era of Digital Nomads.

Nomad Coin is a cryptocurrency that provides a solution to allow merchants to accept crypto as payment for products and or services through an easy-to-use interface, connecting the digital nomad coin community to merchants while allowing full transparency and traceability of transactions. Nomad Coin's services include a P.O.S (Proof Of Stake) for wallet ledger tracking for faster transactions and coin deposit confirmations, an explorer to track transactions transparently, tools to connect nomads to nomad merchants sector.

Additionally, Nomad Coin is a coin to be used as payment to merchants for products and services on the Nomad coin Blockchain which allows Merchants can accept payments in different crypto currencies directly on their Ecom website. 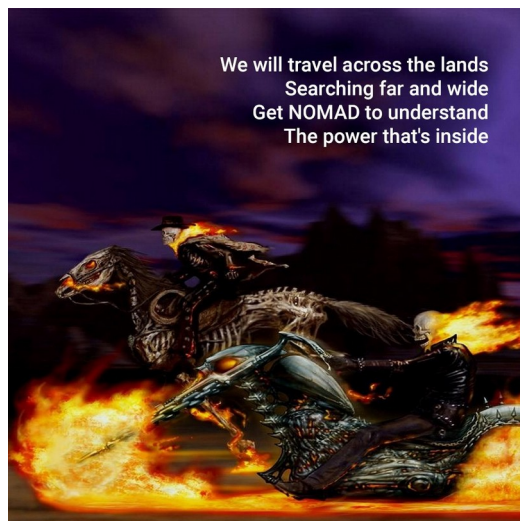


THE CHALLENGE

Nomad's are a single or group of people that travel from one spot to the next only staying for a short period of time or over the season before moving on once again. Nomads come from all walks of life, faith, age and race. Why should they be punished for doing what they must to survive. We all want people to pull there own weight but we must remember not every weights the same, so what it takes you to survive may last some one else longer or shorter in time of usage.



Nomad's do all sorts of things while traveling to make there way. Some work general labor when they can get it, others work remotely from a company, others provide a online service or product to pay what little bills it takes to be able to make it through each day.

THE SOLUTION

Given recent cryptocurrency news, it is understandable that the society has grown skeptical towards the cryptocurrency sector. However, there is a solution that has the potential to transform the industry. Blockchain-powered smart transactions of cryptocurrencies is providing transparency, enabling efficiency and cutting costs.

- **Lower costs:** With traditional transactions, money goes through various middlemen, such as each tx min fee is 0.1 NMD coins (approximately 10% of one whole coin) are charged by wallet to pay the blockchain miners of the chain. Blockchain transactions are executed directly, reaching the merchant instantaneously and at a fraction of the cost.

- **Efficiency:** Thanks to the distributed ledger technology, nomad coin users can track their cryptocurrency transaction to the merchant for payment. No record on the blockchain, in fact, can be erased, thereby providing

traceable account-ability showing the exact flow of the coin in the chain. Merchants too can use the blockchain to manage resources, reduce overheads, streamline their supply chain, and waste fewer resources.

- **Transparency:** If certain based on the payment agreed the user has payment security when the only thing that processes over the wire is the transaction amount and ID and if confirmed deposit or not. Merchants have this with allowing customers to keep theft down and to show the customer that the merchant wants to keep there transaction secure for safety of both parties.
- **Tax Deduction:** Although formal guidance still isn't available, the IRS treats virtual currencies as noncash assets and, therefore, eligible to be treated as long-term capital gain property. Moreover, while for traditional transactions for cryptocurrencies is not applied technology at this time it is always best to follow up on your regions crypto laws and such. If you sell products or services make sure to pay required state and federal taxes as needed, a qualified R.O.I investigation may be required, blockchain transactions are exempt as they are transparently and publicly traded. In order to provide increased transparency and traceability of transactions, merchants could greatly benefit from blockchain technology. Although the benefits of transparency and the potential of cryptocurrency is clear, merchants are poorly positioned to embark on new blockchain-led technology initiatives, since they are focused on their core business: helping the recipients of products or services. However, when they are introduced to new technology which doesn't require them to invest in IT development, merchants see the tremendous benefits it provides.

The benefits of applying the distributed ledger technology to the business sector are numerous as highlighted above. Customers will have more trust in the sector and, consequently, will be more willing to purchase goods & services. To stimulate transparency and traceability in the business sector, we have devised Nomad Coin, a hmq1725 coin that aims to become the preferred method to pay transparently through the nomad coin blockchain and to access the Nomad coin community. The adoption of cryptocurrencies will impact the way we pay for products and services in the future and Nomad Coin is poised to play a leading role in this new era of Digital Nomads and the merchants they buy from.

PUBLIC EXPLORER

The Nomad Coin explorer technology provides a shared transaction ledger which is immutable and allows for full transparency. Records on the block-chain cannot be erased, so when used for cryptocurrency, blockchain technology provides traceable accountability showing the exact flow of any coin in the chain. When someone pays with nomad coins, they can see exactly where and if it was sent and received.

The following are the types of transparency that can be designed for nomad coin merchants:

- Tracking the actual use of funds, from the time money is sent up until its deposit into the merchants local nomad merchant wallet or account.
- Verification of the transaction of the sender and recipients and reporting on the blockchain of their funds.
- Ensuring money paid for specific products or services actually gets to those specific merchants.
- Tracking of the investment policies of merchants with the money they hold.
- Reduction in transaction costs of money transfer through cryptocurrency rather than financial intermediaries.

This becomes especially relevant when dealing with organization that operate in developing countries, where transfer fees for remittances can be as high as 20%

The room for improvement and the uncharted territories of blockchain opportunities are vast. Even those skeptical of the hype and speculation behind many cryptocurrency investments, Barbas and Zuckerman concedes that cryptocurrencies can push forward the conversation about financial inclusion in many promising ways.

The issues plaguing nomads worldwide are innumerable and cannot be countered by relying on traditional methods. Nor can we afford to maintain the status quo or harbor doubts about the impact new technologies can actually bring. Wars, climate change, natural disasters, immigration, and the erosion of the economic state render the services provided by businesses ever more in demand by billions worldwide. 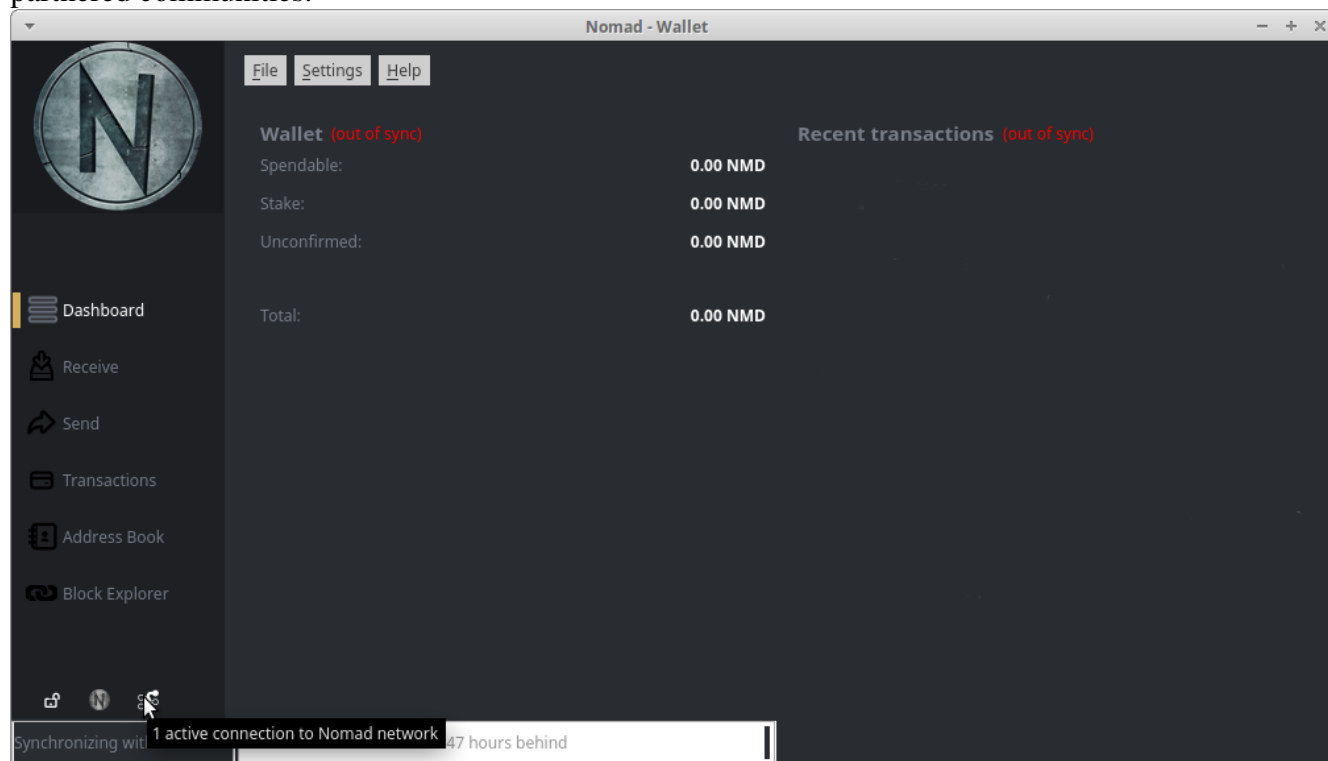

TRACK TRANSACTIONS

GROWTH STRATEGY

Unlike other projects looking to tokenize the business sector, Nomad coin has already developed an platform of digital nomads, investors, celebrities and giveaways that will be key to increase the adoption of the Nomad coin platform. Through established relationships, Nomad coin will be instrumental in signing up the first merchants to Nomad coin.

Also, nomad coin will be the first cryptocurrency platform to give digital nomads a way to pay for products and services they provide to the nomad community. This will of course not limit the merchants that wish to accept nomad coin as a payment option. Digital nomads shop all of businesses. Do you want them shopping with you?

Some benefits to give incentive to the community to use nomad coins are:

- **Discounted price:** auctions will benefit from a 5% discount on the product or service final price. As the platform's average price is say \$20.00 to use the discount they must send 5% of the total price with shipping and tax in nomad coins to the merchant, this then results in a big incentive to digital nomads to want to buy and use the coins as a payment option of merchants product or service.
- **Membership club auctions:** to participate to these special auctions, users will need to stake Nomad coin on their wallet. The amount of coins required will change based on the auction's nature and price. This will enable certain users to bid on some of the most amazing once-in-a-lifetime merchant prizes.

As the adoption of the platform grows and the tracking system gets further developed, Nomad coin will aim at attracting exchanges to the platform by leveraging well established exchanges for which the ability to provide transparency and accountability is key. As of today, 99.9% of coin developers asked have declared that exchanges is a core part of their currency and no longer a one exchange choice option. While exchanges has been proven to create value for both investors and society, the amount raised by users and the destination of the funds is not transparent.

By adopting Nomad coin, merchants will be able to create corporate gifts, rewards for employees, and CSR campaigns which will be fully trackable. Through Nomad coin, user's will have accurate reporting allowing them to improve their employee relations as well as affect outcomes in the areas that their Corporate Social Responsibility (CSR) programs want to impact.

The Nomad coin team has worked with many users and other coin developers, including INFO, K2X, UOF, CFCC, TTPC and EXIST, proving itself as a preferred destination for CSR activities. Following these initial phases, the Nomad coin team will target the onboarding of other merchant platforms including digital nomad products and services, sponsorships for nomad events and community events. boom in businesses accepting nomad coins. Furthermore, as merchants begin to prefer this way of payment, pos platforms will be compelled to adopt it as a standard.



TOKEN DISTRIBUTION

The initial generation of Nomad coin pre-mine = 5% of 210 million and will be distributed as follows (planned for the launch date of January 26th 2018)

- 5% of tokens (5,000,000 NMD) will be allocated to developer coins for growth and advancement of the Nomad coin Project.
- 50% of tokens (15,750,000 NMD) will be allocated to early backers and advisors that have contributed to the

project's success.

- 5% of tokens (5,000,000 NMD) will be allocated to the team for bonuses and payment on projects to advance the growth of Nomad coin.

- 18% of tokens (5,670,000 NMD) will be allocated to the NMD staking Pool's to incentivize Nomad coin adoption, further develop the community and constitute the reserve funds to be used in future monetary policies.

- 18% of tokens (5,670,000 NMD) will be allocated to Nomad coin and will be held as a provision for future expenses, partnerships, business development, marketing and strategic acquisitions. Depending on future developments, a portion of these coins could be allocated towards the reserve funds managed by the Nomad coin. coin amount may be subjected to change in the future of the coin.

3.5% of tokens (157,500 NMD) will be allocated to Airdrops, bounties, giveaways and contests.

0.5% of tokens (1,204,505 NMD) will be used to to stake Nomad coins on auto held by bots.

No swap of Nomad coin will be made. (This may have changed over the launch of the coin)

NOMAD COIN TRANSACTION MODEL

In order to deliver a viable transaction model for the long term, we establish Nomad coin to be a payment currency for products and services from merchant's or for using services available from Nomad coin. According to our long-term view, we foresee two different economic models for Nomad coin which, while ensuring price fluctuations, will aim at stabilizing the price over the long term to avoid triple digit price swings in short time frames.



COIN DEVELOPMENT ROAD MAP

The road-map for Nomad coin is as follows but subject for changes as things advance. This road map was built in late January early February of 2018 and has been a great map to follow for the first year of the coin. Many things has happened and more is yet to come.

OUR STORY

Nomad Coin founder Jeremy Henry is a serial entrepreneur who has proven his tenacity through the numerous ventures he has built from the ground up. At just 21 years old, Jeremy launched his first venture, Henry's Treasure Chest. Originally a catalog order drop-ship for specialty merchandise products, Henry's Treasure Chest unfortunately had a rocky start eventually he closed main headquarters office. Jeremy's next light-bulb moment came unexpectedly when he learned that someone had decided to higher a website designer. Seeing a way to monetize this further growth for the greater good, he enlisted him self for the project and invested his time into the design, launching the first batch of websites in June 2007. By the end of that year, Henry

- 4-8 crypto currency developer partners.
- \$2489.70 registered orders as of 8-23-18.
- Major room for growth.

Operating in a growing \$7 Trillion Global Travel Sector market, the Nomad coin has no designated offices on earth, operating from the road and destinations for not set period of time.

The following are examples of past actions:

Nomad coin covers its own costs by staking a 0.5% on the amount raised through the staking bots, while the rest goes towards the expenses. Examples are on-line marketing, managing coin updates, sourcing and delivery of updates, and community administration. At the center of the coin's success is its ability to provide its users with a global currency and multiple merchants all in one place. This has translated into an impressive merchant list comprised of big names such as Amazon, Wal-Mart and Apple. Approximately 80% of these merchants we want to have signed exclusivity agreements, essentially electing Nomad coin as their preferred crypto currency payment option and setting high entry barriers for other product and service providers.

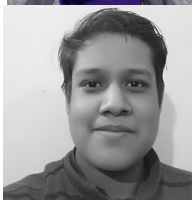

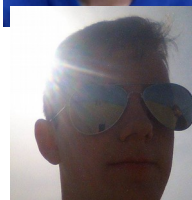
